Mr. "K" Goes to Washington

Though I've been affiliated with Citizens Climate Lobby since 2013, this June was my first Washington Conference and Lobby Day with them. I am very glad I went.

CCL's motto, "creating political will for a livable world" is rendered by two approaches, analogous to EFM's: science leading to advocacy. First, there were two days of in-depth sessions on policy progress, on environmental science (Oceans was my favorite), on the evolution of attitudes (Yale Center on Climate Communications), on collateral efforts like the "Our Children's Trust" lawsuit, and the Climate Solutions Caucus in the House, and inspirational talks to 1.300 of us from several countries. Then

described growing up in San Rafael and Saratoga, around creeks and oak trees. In 4th grade she attended the Redwood Glen EE experience in the Santa Cruz Mountains, where she was turned on to loving the natural environment. She later attended fascinating Nature Study Classes at College of Marin with Al Molino and graduated from Humboldt State in Natural Resources Interpretation. After college, with the Peace Corps in Honduras and Paraguay, she continued her passion as a teacher trainer and wildlands management instructor in two rural environments and cultures.

Moving into her next phase, Ann worked as an educator at The Marine Mammal Center from 1989, leaving in 2013 after 19 years as the Director of Education, The Center located in the Marin Headlands is devoted to rescue and rehabilitation or wild marine mammals. She taught educational programs beginning with the arrival of the California Sea Lions at Pier 39 in 1990 to working as a member of the development team's vision for The Marine Mammal Center's new facility (opening in 2009) and strategic planning for education, doing visitor graphic interpretation leading field trips, on-site programs, media interviews, teacher training, and outreach. Ann had a personal connection to the Forum because the Master Class toured The Center regularly in the 90s and in her last years there, she hosted sessions in the new classroom.

Currently Ann is excited to be working in her home community coordinating the San Rafael Volunteers

http://sanrafaelvolunteers.org/, and she can walk to work. She loves connecting people to resources and staffing events like the Coastal Cleanup, Make a Difference Day, and community service projects, Currently, she is revitalizing San Rafael's Clean Business Program. Ann encourages you to check out the website if you want to learn more or volunteer!

Back to the Forum, Ann thanks the Kohn family, as she was the recipient of the Joe Kohn Scholarship which supported her graduation from the Master Class in 2015. Prior to the Master Class, Ann was mostly an educator, not an advocate, but learned advocacy skills in Master Class.

950 of us attended face-to-face meetings on the Hill with over 500 offices of Representatives and Senators. Each meeting had a carefully prepared volunteer lobby team with the aim of connecting, listening, thanking, engaging, then making a specific "Ask" involving putting a price on carbon, noting responses, and designing a follow-on plan. The results are held in confidence, but I can assure you that the policy conversation is advancing.

It was refreshing and empowering to be part of a respectful bi-partisan approach, involving tremendous coverage of the Hill, and having civil discourse that is moving the needle. I'd be happy to engage further with any EFM Member who wants to learn more
